## Walt Disney World Military Promotion 2026

13 November 25

GFAFB is pleased to announce the **2026 Walt Disney World Military Promotion**. This promotion will run during the period of **11 November 25 through 15 December 26**

The promotion entitles "Eligible Service Members" to receive, up to a maximum of 6 promotional products.

**"Eligible Service Members" defined: Active or Retired members of the U.S. Military, including activated members of the National Guard and Reservists as well as active and retired members of the United States Coast Guard. The Commissioned Corps of the Public Health Service (PHS), and the Commissioned Corps of the National Oceanic and Atmospheric Administration (NOAA) ONLY!**

During the offer period, **4-Day, 5-Day or 6-Day Disney's Military Promotional tickets**, with or without options, may be purchased only by "Eligible Service Members" (or their spouse, but not both) for their family and friends. **4-Day, 5-Day or 6-Day Military Promotional tickets** are limited to (6) per "Eligible Service Members".

All **Walt Disney World Military Promotional tickets** are exchange certificates and will need to be exchanged/activated at the Main Entrance theme park ticket windows (no later than 13 - 18 December 2026) in order to be used fully. **Disney's 4- Day, 5-Day or 6-Day Military Promotional Tickets (including any options) expire and may not be used after 18 December 2026.**

### Dates of Use

Disney 4 Day, 5 Day or 6 Day Military Promotional Ticket - Exchange Certificate may be used 1 January 26 through 28 March 26, 12 April 26 through 21 November 26, 29 November 26 through 18 December 26.

Disney 4 Day, 5 Day or 6 Day Military Promotional Ticket - Exchange Certificate may not be used on the following **blockout dates: 29 March 26 through 11 April 26, 22 November 26 through 28 November 26.**

**Disney Four (4), Five (5) or Six (6) Day Military Promotional Tickets (including any Park Hopper® or Park Hopper® Plus Options) expire and may not be used after December 18, 2026** (and, accordingly, Disney Four (4), Five (5) or Six (6) Day Military Promotional Ticket Exchange Certificates may not be exchanged for Disney Four (4), Five (5) or Six (6) Day Military Promotional Tickets after December 18, 2026).

**Special Provisions:**

1. The General Terms and Provisions for Tickets previously furnished apply to these Exchange Certificates as well.
2. These Exchange Certificates may be exchanged by the Eligible Service Members (or their spouses) for the corresponding 4-, 5- or 6-Day Disney Military Salute Tickets. To receive these Tickets, the Eligible Service Member (or their spouse) must present an Exchange Certificate, together with valid military identification, at a ticket sales location at *Magic Kingdom Park, EPCOT, Disney's Animal Kingdom Theme Park or Disney's Hollywood Studios*. These Tickets will not be valid until activated by the Eligible Service Members (or their spouses) at a *Walt Disney World Resort* ticket sales location (hereinafter referred to as "Ticket", "Tickets", or "Military Salute Tickets").
3. Prices and ticket products and features are subject to change at any time.
4. The net rate of these Tickets will be quoted by the TTC System.
5. Tickets and options exclude activities/events separately priced or not open to the general public.
6. The "Ordering Period" will be November 11, 2025 through December 15, 2026, in the case of the 4-Day Disney Military Salute Tickets - Exchange Certificates, November 11, 2025 through December 14, 2026, in the case of the 5-Day Disney Military Salute Tickets - Exchange Certificates and November 11, 2025 through December 13, 2026, in the case of the 6-Day Disney Military Salute Tickets - Exchange Certificates.
7. These Tickets may be purchased at participating U.S. military sales outlets ONLY by Eligible Service Members (defined below) or their spouses, for use by themselves, family members and friends, in accordance with these Special Provisions. These Tickets may not be otherwise transferred or resold.
8. **"Eligible Service Members"** are active or retired members of the U.S. military, including the National Guard, Reservists, the U.S. Coast Guard, the U.S. Space Force, the Commissioned Corps of the Public Health Service (PHS), and the Commissioned Corps of the National Oceanic and Atmospheric Administration (NOAA). Spouses of Eligible Service Members also qualify if they can present valid and active U.S. Military IDs.
9. Participating military sales outlets must require that Eligible Service Members (or their spouses) present valid military identification to purchase these Tickets.
10. These Tickets may be used January 1, 2026 through March 28, 2026, April 12, 2026 through November 21, 2026, and November 29, 2026 through December 18, 2026, with an advance park reservation.
11. These Tickets may not be used on the following blackout dates: March 29, 2026 through April 11, 2026 and November 22, 2026 through November 28, 2026.
12. These Tickets (including any *Park Hopper* or *Park Hopper Plus Options*) expire and may not be used after December 18, 2026.
13. To enter a theme park, both a theme park reservation and valid ticket are required. Before purchasing these Tickets, Guests should check that reservations are available for this Ticket for the date and park they would like to visit. Guests should make their reservations immediately after purchasing this Ticket because reservations are limited, and Guests may not be able to get a reservation for their desired date or park. Reservation availability is not guaranteed for any date. Reservations may be unavailable for any particular date or park, especially as a Guest gets closer to the date of visit or Ticket expiration date. For any given date, other admission types may be available for purchase and reservations may be available for other admission types even though reservations for this Ticket are fully reserved.
14. With the purchase of these Tickets, Guests become eligible to make park reservations to visit during their ticket usage window. Park reservations are limited in number and subject to the availability of park reservations allocated to the applicable ticket as determined by Disney, applicable blackout dates and theme park capacity. Ticket blackout dates are dates on which a ticket is not valid for park admission and not eligible to make or hold any park reservations. A ticket does not guarantee park entry, even on dates when a ticket is not blocked out. Disney determines the number of park reservations available to holders of this ticket type for any date, and ticket holders may access only those reservations that Disney makes

available to their ticket type. Once all park reservations made available to a ticket type for any date are reserved, holders of that ticket type may not make reservations for that date using their ticket unless and until reservations become available due to cancellations or Disney makes additional reservations available to such ticket holders, which Disney is not required to do, but may or may not do from time to time in its discretion. On any given date, park reservations may still be available for other admission types and/or other admission types may be available for purchase, even though park reservations are not available for certain tickets. Ticket holders, regardless of their ticket type, are not entitled to any or all reservations Disney makes available to others on any date, to all reservations up to park capacity on any date, or to any minimum number of reservations on any date. Even for dates that are not blocked out to a ticket type, it may not be possible for ticket holders to get park reservations to visit on their preferred dates or preferred theme park, including popular dates like weekends or holiday periods. Since park reservations are available on a first-come, first-serve basis, it may not be possible for ticket holders to get park reservations for certain dates or parks. Park reservations are nontransferable and void if transferred or sold. Park reservations are not guaranteed for any specific dates or park, no matter the ticket type. Disney reserves the right to change or cancel ticket features and benefits, including park reservation requirements, at any time without notice or liability. Different admission types may have different (or no) reservation requirements from time to time or at any given time. Other restrictions, such as the time during which a ticket holder may hold or make reservations, may apply, and may change from time to time in Disney's discretion without notice or liability.

15. During the Ordering Period, no more than a total of six (6) of any Military Salute Tickets (including "Disney Military Salute Tickets" and "Disney Celebrates America Military Salute Tickets") may be purchased by any Eligible Service Member or spouse (regardless of the ticket type, place of purchase and whether purchased by the Eligible Service Member or their spouse). In addition, one of the six (6) Tickets purchased must be used by the Eligible Service Member or their spouse. Or, if the Eligible Service Member or their spouse has a valid *Walt Disney World* Resort Annual Pass at the time of purchase and at the time this Ticket is used, then: (1) such Eligible Service Member or their spouse is not required to purchase this Ticket for their use; and (2) no more than a total of five (5) Tickets may be purchased by such Eligible Service Member or their spouse (regardless of the ticket type, place of purchase and whether purchased by the Eligible Service Member or their spouse).
16. Any Eligible Service Member, or their spouse, who purchase any Military Salute Tickets (including "Disney Military Salute Tickets" and "Disney Celebrates America Military Salute Tickets") from a participating U.S. military sales outlet in excess of the six (6) or five (5), as applicable, limit (e.g., any Eligible Service Member or spouse who purchases these Tickets at a participating U.S. military sales outlet after having previously purchased these Tickets at any other place) must be permitted to return the excess (unused) Tickets to that outlet for a full refund, and we will not be entitled to payment from you for any such excess (unused) Tickets returned to us. Each Eligible Service Member (or spouse) must be asked to confirm, before purchasing these Tickets, the quantity (if any) of Military Salute Tickets that person or that person's spouse has purchased at any other military sales outlet or place during the applicable time.
17. These Tickets are nontransferable and must be used by the same person on any and all days.
18. Valid military identification will be required for activation and use of these Tickets.
19. Each Eligible Service Member (or spouse) will be asked to confirm, before purchasing these Tickets, that neither that person nor that person's spouse has purchased any other Military Salute Tickets at any other military sales outlet or place.
20. Parks, restaurants, attractions, entertainment and other products, services and items are subject to change, closure, cancellation, varying levels of availability, and discontinuance without notice due to rehabilitation, refurbishing, capacity, seasonal considerations, weather, low demand, government or other authority guidance or order, pandemic-related restrictions, special events, or any other reason without liability to Disney or any of its affiliated or related companies. Water parks are subject to extended rehabilitation, seasonal, capacity and weather closures or may close for other reasons. On certain dates a water park may only be open for special events or to limited groups.
21. Park admission, offerings and ticket options are not guaranteed.

22. We have the right to cancel any Ticket or any feature or features of any Ticket at any time and for any reason and provide a refund. Tickets are nonrefundable unless cancelled by us or as otherwise provided in this Attachment 1. If we cancel a Ticket due to misconduct of the holder, no refund will be due.
23. Prices, terms, features and entitlements are subject to restrictions, and change or cancellation without notice or liability.

These Tickets are subject to the *Walt Disney World* Resort Ticket Store Terms and Conditions available at <https://disneyworld.disney.go.com/tickets-terms-conditions/>, including the Binding Arbitration Agreements and Class Action Waivers. In the case of any conflict between the *Walt Disney World* Resort Ticket Store Terms and Conditions and this Attachment 1, the *Walt Disney World* Resort Ticket Store Terms and Conditions control.
25. The above limitations must be disclosed to each Eligible Service Member (or spouse) before that Eligible Service Member (or spouse) is permitted to purchase any of these Tickets.
